

What is Audit IT?



For years, auditors in Iran have used their traditional method to examine the documents of owners. But today in international circles, auditing through computer-based tools and techniques is not a new issue and the existence of an intelligent computer system for any knowledge-based firm is not a choice but a management requirement.


Audit achievements by Audit IT method

What is BPMS?

BPMS stands for Business Process Management Software that provides a graphical environment which enables you to integrate and mechanize your organization's current processes with the least programming knowledge.

Advantages of using BPMS

- Integration of all existing systems through the business process management system
- Optimizing the relationship between units and accelerating the execution of processes in the firm
- Optimal use of organizational resources and reducing risks and costs and increasing productivity in the firm
- Preparation of various control and monitoring reports of all current operations and progress of tasks in the firm

Sample reports that can be generated in BPMS for auditing firms

- Customers to whom the audit contract was sent but who did not sign and return the contract
- Customers for whom the audit contract has been sent and returned but has not paid the down payment
- Customers for whom the contract has been sent but that contract has been canceled
- Customers whose contract has been signed and received but is not registered in the Kodal and Sahar systems
- Customers whose audit report has been submitted but whose final bill has not been settled
- Customers who have deducted from the amount of the insurance deposit contract or good performance
- Clients to whom an audit report has been submitted but the report issued has not been registered in the Sahar system
- Customers whose insurance policies have been obtained and not delivered to them
- Customers for whom insurance policies have been obtained but have not released an insurance deposit
